グローバル時代、境界を越える人的交流がますます活発化する中で、コミュニケーションに不可欠な言語の問題が社会的な重要性を帯びてきます。国家が公用語を定めたり、少数派の言語を保護したり、特定の表記を公式なものとしたりする「言語政策」と、その具体的な実施段階である「言語計画」は、国家における統一と多様性、グローバルとローカル、実用性とアイデンティティなどの種々の対立軸の間で、難題であり続けてきました。多様な言語とコミュニティがひしめくアジア地域全体を対象として、言語政策と言語計画の問題点を検証することは、アジアの共生の未来を開く必須の作業といえましょう。

本書は、日本語教育・英語教育と言語政策・言語計画を結ぶ代表的研究者である宮崎里司・飯野公一 (早稲田大学) を編者に迎えて、日本とアジアにおける言語政策・言語計画上の主要論点を総括する、必読論文55点を精選収録します。第1巻は、東アジア・南アジア・ASEAN地域におけるマクロな言語政策上の論点を対象とし、例えば、言語と移民政策を取り上げます。第2巻は、英語教育と英語検定が社会経済的格差ともかかわる問題に、マレーシア、ミャンマー、インド、日本の事例から光を当てます。第3巻は、21世紀のアジア各国に急速に広がる英語専門教育 (EMI) と国際共通語としての英語 (ELF) を議論します。第4巻は、英語以外の言語 (継承語や手話なども含む) の問題に焦点を当てます。
